I. Call to Order

President Pratus called the meeting to order at 5:30 p.m.

II. Open forum for citizen comments and questions (limited to five (5) minutes per person)

There were no citizen comments.

III. Discussion and possible action concerning approval of the minutes dated October 21, 2020

Board member Leavell moved to approve the minutes as presented. The motion was seconded by Board member Schaub. The motion carried unanimously (Vineyard, Millican and Carroll absent).

IV. Discussion and possible action regarding development & funding of Phase 1 infrastructure for the LEDC Business Park

Mandy Walsh, Economic Development Director, advised the Board they are postponing the submission of the EDA Grant. The business prospect was advised to contact Walsh again when they have gathered more information. Ms. Walsh suggested the discussion on infrastructure be placed on the January meeting agenda.

No action was taken.

V. Update and possible action regarding the Texas Economic Development Connection

Paul Tarrants with Texas Economic Development Connection (“TEDC”) presented, by phone, their marketing initiative to assist in creating interest in new development, job creation and expansion. Tarrants informed the Board that they are currently looking for new partner investments in the amount of \$2,750 for the year 2021.

TEDC Partnerships enhance existing local, regional, state and national marketing efforts with diverse tools in digital marketing, podcasts, print pieces, promotional items and events.

Board member Schaub moved to approve the partner investment amount of \$2,750 to Texas Economic Development Connection. The motion was seconded by Board member Leavell. The motion carried unanimously (Vineyard, Millican and Carroll absent).

VI. Discussion and possible action regarding 2020-2021 LEDC Strategic Plan

Mandy Walsh discussed the Strategic Plan for the 2020-2021 fiscal year.

Topics of discussion included:

- The Internet goal is 90% complete from the 2019-2020 Strategic Plan.
- Retail Coach provided valuable information, which has been and will continue to be used for downtown revitalization and retail recruitment.
- The possibility of hosting a job fair in 2021 and educational workshops to fill gaps on economic trends.
- The high demand in existing structures for prospects sent through State RFI’s.
- Promotion of grant opportunities for businesses through Business Retention and Expansion (“BRE”) program.

No action was taken.

VII. Update and possible action regarding October Financials

Mandy Walsh reviewed the financials with the Board. Receipt was acknowledged without formal action.

No action taken.

VIII. Discussion and possible action regarding cancelling December LEDC regular meeting

It was the consensus of the Board to revisit this Agenda Item closer to the meeting date of December 16, 2020.

No action or discussion was taken.

IX. Update on the following:

1.) County Updates

There were no updates on the County due to the absence of Ex-officio member Carroll.

2.) Lampasas Independent School District Updates

There were no updates on the County due to the absence of Ex-officio member Millican.

3.) Staff Updates

Mandy Walsh, Economic Development Director, reviewed the following:

- SBDC – The Small Business Development Center reached out to Walsh regarding a list of qualified businesses to participate in the Department of Defense (“DoD”) supply chain. The Restart Program was also introduced as a way to assist businesses in reworking their business strategy in order to sustain, grow and provide a more diverse supply chain.
- Development – Walsh notified the Board that Mike Irvin has begun demolition at the former Hermann Feed Store. Golden Chick is anticipating an opening date shortly after Thanksgiving. The Community Church plans to go vertical soon. Heritage Funeral Home is moving along and has installed the fire line. Alamo Coffee will be opening soon and will be adding a second floor for seating.
- BRE – Walsh advised she recently met with a business owner looking to expand an independent living facility by the end of this year due to increased demand.
- Connected Nation – Connected Nation and CTCOG are currently sending out a survey within Lampasas County regarding broadband in rural areas. CTCOG has been awarded CARES Act funding to assist with obtaining a broadband plan for rural areas and may request assistance in distributing surveys. Walsh informed the Board she has a follow up call with Connected Nation to learn more about the project in January.
- Residential Development – Development in the City has generated a lot of interest and activity this year. The City is structuring agreements with two subdivisions, Hillside Acres and Hidden Oaks. Brodie Estates has signed their agreement and has all of their underground electric in place. Stone Valley is still progressing with 34 permits issued of the total 67 houses. There are

also conceptual plans from another builder interested in building approximately 15-17 homes north of Diamond Ridge.

- Events – December 11th will be Christina Marez’s reception for retirement. The Carol of Lights will be December 5th with no Santa Claus or Mrs. Claus interactions due to COVID-19 restrictions. Christmas on the Creek will be December 12th and will be scaled down as well. The Fire and Police Department will host their annual Toy Drive and Christmas Luncheon on December 14th at the Fire Station.







CDI

I signed up for the Community Development Institute again. This year I'll attend the Advanced 2-day course at Lonestar College in The Woodlands, but the dates have moved to November instead of March. This training focuses on the application of community and economic development principles in a real-world setting. The two-day training is designed for those that have completed three years of CDI and is recognized by the CDC for education requirements, training, work experience and eligibility criteria for PCED re-certification.

PPP

I sent out an email to business owners last week regarding the latest round of PPP funding and other recovery resources through the U.S. SBA. The Governor's office is hosting a webinar with a panel of experts, including Senior executives from the SBA and SBDC to provide up-to-date information on the application process, loan forgiveness and other pandemic assistance for small Texas businesses and entrepreneurs. The virtual event will also have a Q&A session so I'm hoping Lampasas business owners take advantage.

Current Development

Golden Chick (Hwy 190) opened earlier this month and the owner reports he's been very pleased with the reception. Endeavor Real Estate closed on the property at 1003 S Key Ave and City Council approved the utility agreement. We are awaiting comments from the third party civil plan review. Structural/architectural plan review should finalize within the next week. Heritage Funeral home is close to completion and has been issued a TCO; staff is awaiting plans for the crematorium. There is a new spa & gym development planned along Hwy 190; third party civil plan review has been completed and staff will review and send comments to Eckermann Engineering. Third party civil plan review has been completed and returned to the developer for the project at 1699 Central TX Expy. On the residential side, staff has issued two building permits recently for the planned 22-home Brodie Estates development. Stone Valley has now permitted 38 homes with 22 COs issued out of the total 67-home development. Civil plans have been reviewed and approved, and the development agreement is being finalized for the Hidden Oaks development. Hillside Acres was issued a site waiver to begin in November. Staff has engaged a third party for a civil site review of current and future planned development at Hillside Acres. Staff has also received an application from a potential downtown business owner applying



for the Life Safety grant for their building. Staff and review panel will meet and discuss within the next week.

Internet

Nextlink and Roll-Call are continuing their fiber buildout within the City. Nextlink is currently installing in the Fawn Acres subdivision on the west side of town, while Roll-Call is working in Sunrise Hills on the east side. Nextlink has communicated their plan to build out in Fawn Acres first, then Stone Valley, followed by Horseshoe Bend; each taking approximately 2-3 weeks from start to finish. Door hangers, and other forms of marketing, will be used to reach out to the residents of each neighborhood prior to buildout. Residents can also be directed to the websites for each ISP, list their address and confirm they are in the service area in order to sign up for internet service.

Connected Nation

The CTCOG and Judge Hoyer have asked that I serve as the lead contact for Lampasas County with Connected Nation's joint broadband community engagement project for Lampasas/San Saba counties. I spoke to their team to get a better understanding of the project and my role. Connected Nations is working with Texas Rural Funders (private foundation) to identify and work with 27 rural communities in Texas on the challenges with access, adoption/subscription and use of broadband in these rural communities. The data they collect, with the assistance of a local broadband team, will help them build an interactive technology action plan. ISPs in the area will be alerted of this data collection and attracted to serve portions of our county. We will have a kickoff meeting in February with a local team of leaders and weekly project update calls. They anticipate this taking no more than 90 days from start to finish.

Comp Plan

Staff continues to proof the City's draft Comprehensive Plan. There have been a few recent ideas from prospective business owners that have highlighted possible changes needing to be addressed in the Comp Plan in regards to land use. Other policies being drafted involve marketing and development of assets. Staff is scheduling a phone call with the Half & Associates team to review comments. Their team will update the draft, and staff with schedule steering committee meetings to review and begin plans for implementation.

Sales Tax

The City is still seeing a healthy increase in sales tax. The January collections indicate a net payment of \$189,712.92 compared to \$159,062.99 for the same period one year ago. This reflects a 19.26% increase. With four months of receipts, the City has already collected 43% of the annual sales tax budget.

Bike Trails

The Parks Department has been working with the International Mountain Bicycling Association, and they will be in town the week of January 18 to review the 580 Sports Complex site for design and development of bike/multi-use trails. This was a concept brought to City Council in 2020 by a

citizen. Council has been in favor of the idea and understand most of the initial construction costs will be donated, and not an expense to the City.

EDA

The EDA Cares Act funding we began applying for last year (and have since suspended), with the 80/20 match, has been exhausted. After speaking with our grant writers, there is the option to apply for the standard EDA grant, but it's a 50/50 match with a minimum \$1 million investment from the community and substantial job creation (100+) from the prospect. This will not be the disaster relief funding we initially considered, but if we identify a prospect to partner with we could look at applying for next year's funding beginning this June.

EDP Best Practices

Working with EDP regarding Sites & Buildings marketing for the website. This company provides various tools to promote available properties including: 1) Sites & Buildings Summary to quickly provide a broker or prospect with every available property in our area; 2) single page Site-Building flyer to use for marketing particular sites or buildings; and 3) Business Park Marketing document summarizing all aspects of the Business Park to allow for quick responses to prospect opportunities. This is a tool we've been needing on our site as we continue to see an increase in inquiries from prospects. There is a list of available properties we keep updated, but in addition to print pieces, this will provide a visual on our website for prospects to access and review.

Leadership Central Texas

The CTCOG is hosting a Leadership Central Texas 2021. Training will be held one day each month during the summer of 2021 on June 17, July 16 and August 18 from 9 a.m. to 4 p.m. Applicants are (at least ONE of the following) citizens demonstrating a desire to serve in a leadership role, a past/present elected official of the community, region or state and/or have completed (or enrolled in) a local leadership program in his/her community. The purpose of Leadership Central Texas is to identify and develop regional leaders, who live or work within the seven-county region served by the CTCOG, and to promote awareness of regional/state leadership opportunities, social services, infrastructure and economic development. Topics are taught with active participation from leaders on regional boards. Each certified attendee will be encouraged to identify leadership opportunities where their individual talents would best be applied to insure the growth and future well-being of our Central Texas Region.
